Human rights defined

- Human rights are based on the principal of respect for the individual
- Their fundamental assumption is that each person is a moral and rational being who deserves to be treated with dignity. *They are called human rights because they are universal.*
- Whereas nations have specialized rights that apply only to them, human rights are the rights to which everyone is entitled – no matter who they are or where they live – simply because they are alive

What makes people different ?

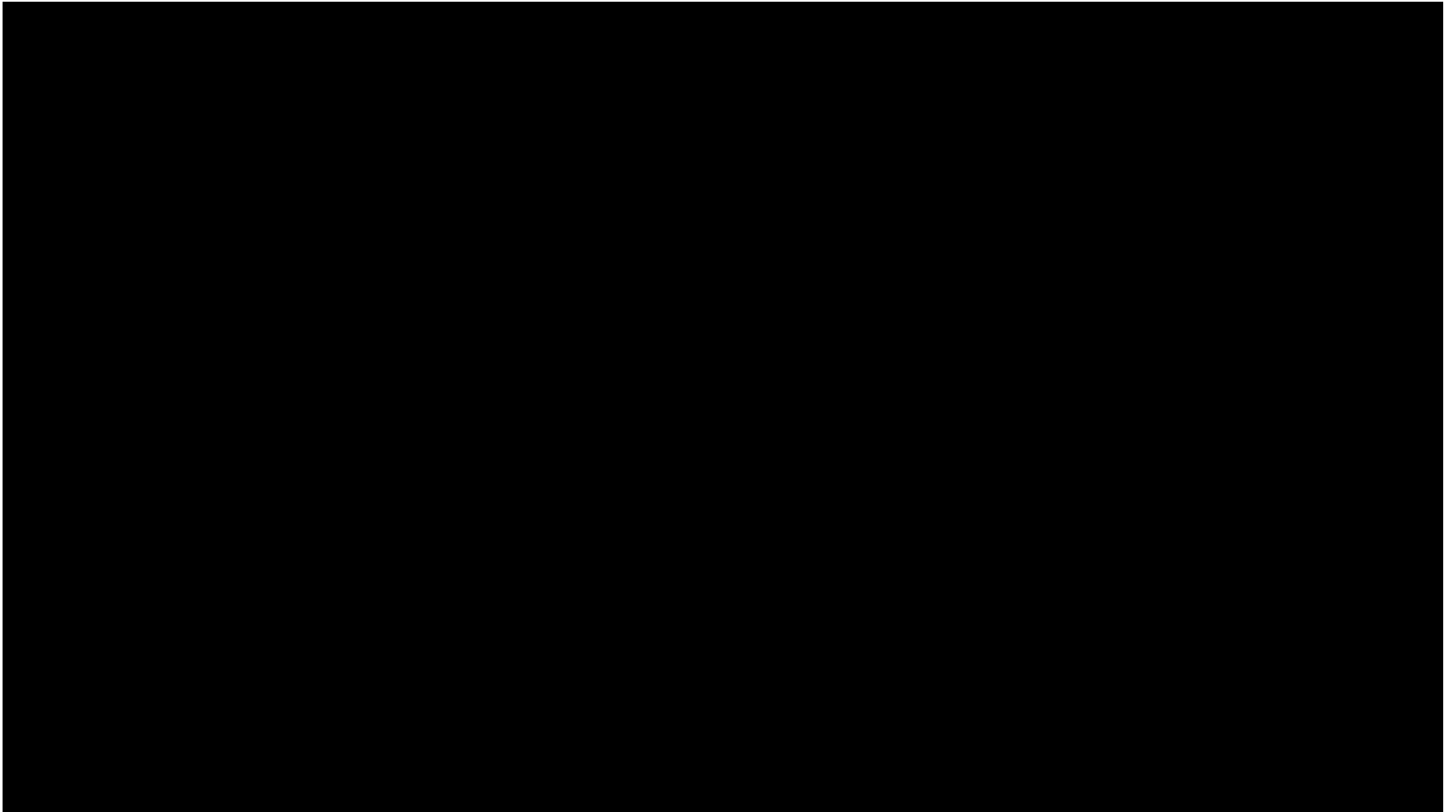
- The color of our skin

What Is Diversity?
